THE UNTOLD STORY OF TWO WOMEN IN LOVE WHO HELPED CHANGE MILITARY POLICY

When Col. Patsy Thompson was forced to expel Army hero Col. Margarethe Cammermeyer for being a lesbian, no one knew she was as well. The way she handled the military trial, however, led to Cammermeyer's re-instatement via federal court and eventual change in military policy.

In addition to revealing history, Thompson and wife Barbara Brass candidly share how they wrestled with heart-wrenching choices, hiding their relationship, and struggling to protect their love while preserving Thompson's career – and, how they emerged to become vibrant activists later in life.
